Cardholder hereby agrees to abide by all rules, regulation rates, and charges as prescribed by Pyramid Movers, currently effective and applicable tariffs on file with the Public Utilities Commission of the state of California, including but not limited to the following terms and conditions.

- A. The shipper, upon tender of the shipment to Pyramid Movers. and the consignee, upon acceptance of delivery of the shipment from Pyramid Movers, shall be liable, jointly and severally, for unpaid applicable tariffs including but not limited to the sums advanced or disbursed by Pyramid Movers on account of such shipment. The extension of credit to either shipper or consignee for such unpaid charges shall not thereby discharge the obligation of the other party to pay such charges in the event the party to whom the credit has been extended shall fail to pay such charges.
- B. The shipper shall indemnify Pyramid Movers against loss or damage by inclusion in the shipment of explosive improperly packed or dangerous articles of goods.

I further agree that should any controversy or dispute arise between shipper and Pyramid Movers, due to but not limited to loss, damage, injury or delay, shall not prevent and/or hamper the process in accordance with the Public Utilities Commission of the state of California.

I hereby agree and understand by signing this form, I may in fact be waiving certain rights that are in effect and that may exist between the cardholder and credit card company, and that this form will supersede any such agreement.
